




### Life Changing Injury Compensation Claims

Life Changing injury compensation claims are legally complex. Typically the amount of compensation someone will need after suffering a life changing injury will be measured in six or seven figures.

Just as the medical care you need after injury is specialised; finding and engaging with a solicitor with genuine and specialised experience and expertise in helping patients with life changing injuries and their families is vital.

### "Exceptional Service, Personal to you"

It is important that you connect with the solicitor dealing with your claim, as they will be in communication with you throughout the period of your claim and this could go on for a few years. ### **Examples of Life Changing Injuries**

We help with compensation claims arising from injuries of utmost severity caused on the roads, at work, in public places, and through clinical negligence. If the injury happened as a result of someone else's negligence, it doesn't matter to us where it arose. Examples of cases we are helping with.

Life changing injury cases that have concluded recently or we are currently working on:

- Brain injury to teenager waiting for bus and hit by delivery driver.
- Above-knee amputation to former firefighter caused by missed diagnosis of DVT.
- Multiple fractures to train driver's face neck, hand, knee and leg as well as nerve injury in head on motorcycle collision.
- Multiple spinal fractures caused to accountant in road traffic collision.
- Missed diagnosis of cancer affecting deputy head teacher.
- Needlestick injury leading to sepsis and necrotising fasciitis caused in workplace to young adult.
- Traumatic removal of eye caused to delivery driver while at work.
- Spinal cord injury to electrician riding at mountain bike centre.
- Negligent anastomosis surgery leading to removal of most of bowel in young newly married teacher.









### Examples Of Cases We Have Settled... The People We Help Are Just Like You

### Motorcyclist

Our 20 year old client was involved in a motorbike collision and sustained a spinal fracture resulting in serious spinal cord damage. As a consequence, our client has been left with severely reduced mobility, impaired dexterity and significant pain and now requires 24 hour care. We obtained significant interim payments which enabled our client to access specialist care, case management, physiotherapy and equipment whilst his claim was ongoing. The damages were awarded at a capitalised value of approximately £16m and consisted of damages for loss of earnings, care, case management, aids and equipment, accommodation, medical costs and therapies.

### Driver

Our client was driving her car when the Defendant crashed into the side of her vehicle. She sustained a range of injuries and she was unable to work again due to sensory and mobility problems. Although she could walk, she struggled with excruciating pain in her right forearm caused by extensive nerve damage. Our client underwent a pain management programme as a result of the expert evidence we obtained whilst her claim was ongoing. The claim had been pursued by a previous solicitor and our client had been advised to accept a modest sum when she sought a second opinion from us. We eventually settled the claim prior to Trial for a substantial six figure sum, more than 44 times the amount our client had been advised to accept by the non-specialist solicitor she had engaged initially.

### Cyclist

Our client was a sixth form student who was injured whilst riding his bicycle to school when a lorry cut across him whilst trying to turn into a side road. They suffered multiple injuries including a fractured neck, punctured lungs and a broken pelvis. E has made a good recovery from the physical injuries sustained but has been left with significant PTSD. This has in particular been compromised by his Asperger's Syndrome as well as his domestic circumstances. Interim payments were secured to enable E to access private physiotherapy, CBT and to engage with a Case Manager. The Claimant has undergone CBT as recommended by our psychiatry expert. He made a good recovery and went on to University. The case settled for a substantial sum.

### **Pedestrian**

Our client fell 41 feet down a concrete structure on the side of the motorway. After breaking down, our client climbed to the top of the grass verge before stepping on a concrete platform. Unfortunately the concrete platform was rotten wood and she fell to the bottom. Our client suffered multiple fractures to the spine, severe fractures to the ankles and feet and dislocations in the ankles and feet. She was left with long term pain and limited mobility especially in comparison to her very active lifestyle before the accident. Our client luckily made good progress and returned to work. She will however need assistance with day to day tasks in the home. Damages were secured with a substantial six figure sum.
